Mini-Survey is a Precursor to the NC Plan

ARCA neighbors were asked to provide feedback via email on what they value about our neighborhood. 39 responses were received to the question: What do you like most about living in Arlington Ridge? The mini-survey showed that the best thing about Arlington Ridge is the location. 29 responses included comments on the proximity to D.C, shopping, entertainment, airport, and other destinations, many of which are accessible by walking. Other advantages included: "island in time character", "neighborhood feel in a big city", "friendly", "wonderful community", "a variety of architecture and the many trees [that] make it a visually interesting neighborhood", "something for everyone", and "proximity to bike paths". And we learned something new with this comment: "Although our large trees were cut down during the Civil War, their descendants are still part of our neighborhood. There are over 100 native species of trees, shrubs, and plants in Fort Scott alone."

The mini-survey was intended to broaden members' input into the newsletter, and to get residents thinking about neighborhood issues. The Neighborhood Conservation (NC) survey will solicit input on a number of topics, and will be used as the foundation for the proposals in ARCA's NC Plan. The survey has been developed by ARCA and approved by the County. We are working to create an online form to make it easy to collect the data and analyze results. A paper survey will also be available. We hope all ARCA members will participate in the process over the next few months.

Development Progresses in South Arlington

As development continues in S. Arlington, ARCA is working to establish a framework that consolidates our voices and provides our vision to the County by using the upcoming neighborhood survey, the Crystal City Citizen Review Council (CCCRC) and our involvement in the Long Range Planning Committee. We need your input and feedback to ensure that we are capturing your vision for the neighborhood. Crystal City Redevelopment

The Implementation Phase is Beginning

The County Board adopted the Crystal City Sector Plan (5-0) on Sept 28th. Specific guidance was given for the implementation of the plan in areas of housing, public space, connectivity, transportation infrastructure, energy and monitoring of the plan. Two areas of this guidance are of particular interest to our community. First, infrastructure improvements must commence in advance of major development. In order to furnish funds for the effort, a tax increment finance (TIF) district encompassing Crystal City and Pentagon City Metro Districts including Potomac Yards was established at the October board meeting. TIF is new to Arlington although it has been used in many other areas. It is NOT a new or additional tax. "It supports development and redevelopment projects by capturing the increase in property tax revenues created by the development or redevelopment area and investing a portion of those funds improvements associated with the project." Basically, it is using future gains in taxes, in this case property taxes, to finance current development. A portion of the property taxes paid on properties in the TIF district will be used to pay for roads, light rail, etc. in Crystal City. The second piece of the guidance specified establishment of CCCRC comprised of Crystal City (CC) residents, CC business owners, CC landowners, adjacent civic association representatives, and a representative from each of the Planning, Housing, Environment and Energy Conservation, Parks and Recreation, and Transportation Commissions with support from County staff. The CCCRC will develop metrics and then evaluate progress against these metrics on all dimensions of the Sector Plan. They will identify adverse impacts: monitor traffic impacts on major streets an refer back to county for mitigation where appropriate; in collaboration with the Planning Commission, consider new urban design auidelines that address the transition areas west of US-1; and consider, with the Housing Commission, numeric goals and options for additional financina resources or tools to help fully achieve the County's vision of Crystal City as a mixed housing community. ARCA is working with the County Board to develop the charter for this team. This concept of a citizen-led assessment team using defined metrics to provide feedback to the County is new for Arlington and should give our

community a true voice in both assessing development impacts as well as recommending modifications. We want to hear from you on your ideas on tracking metrics as well as ARCA's membership and support team for the CCCRC.

With the establishment of a TIF district, the funding strategy was completed. We are already seeing movement from the developers. The owners of the property at the corner of Eads and 18th Sts. are considering their development options as the post office moves to the Metropolitan in the coming year. Development on 23rd St. between Clark/Bell Sts. and Crystal Drive is also being considered.

Pentagon City – Penn Place

Potential Density Increase Being Considered

In addition to the initiatives in Crystal City, a Phased Development Site Plan (PDSP) amendment has been submitted for Pentagon City. Vornado is proposing four office buildings (2 DoD, 2 commercial) and a hotel on the tract bounded by Army-Navy Drive on the North, and Eads St. and Fern St. on the east and west respectively. The southern boundary will become the continuation of 12th St. between Crystal City and Pentagon City, where 12th St. runs up to the Fashion Center.

We have received the Vornado proposal and had preliminary discussions with their representatives and County planning staff. The plan presumes a higher site density than the current PDSP through a fairly complex combination of density transfers from North Tract sites as well as granting of bonus density. At our Nov. meeting, Natalie Sun from the County will brief us on the basic proposal framework including density swaps, and Vornado will follow with plan details. One item of interest is whether this proposed transfer of density will set any precedent for future Pentagon City development.

Are your house numbers clearly displayed?
