#### PROPOSED RE-DEVELOPMENT ON JOYCE ST. CUL DE SAC Mr. Troutman and County staff to attend ARCA meeting

Mr. Dan Troutman has accepted an ARCA invitation to explain his proposal for redeveloping the property at 2816 South Joyce Street (cul de sac off Fort Scott Drive). Mr. Troutman would like to remove the existing house and build three houses on a 20,000+ square foot pie shaped lot. A representative from the County staff will also attend the meeting. Last October Mr. Troutman and his business partner Mr. Dennis Zauner purchased the property. In the fall they filed a plat to build three houses by utilizing a "paper street" extension of June Street that runs to Oakcrest Park ("The Pit"). Two houses would enter off June Street extended, and one house would front off the Joyce St. cul de sac. In January, a new plan was filed that has a new cul de sac being built off the existing cul de sac. The three lots would originate from the new cul de sac and extend toward the back of the property. This redevelopment would take place under the Unified Residential Development (URD) code of Arlington County. Please come and learn about this very important possible development for our community and express your views. An ARCA "position" could be established at this meeting. On Jan. 10, the developers held an informational meeting for neighbors to consider the two perspectives. Neighbors were concerned about adding 3 houses to the cul de sac, and about setting a precedent. The County Board is scheduled to hear this issue on March 10.

### EDGE DEVELOPMENT TO BEGIN AT OLD POST OFFICE SITE

The owner of the old Post Office site has reached a deal with Kettler to build a residential development, and plans are scheduled to be filed with the County by the end of January.

## DEVELOPMENT UPDATES Crystal City Citizen Review Council (CCCRC)

On December 12, 2011, the full 19-member Council met to review the transportation metrics to be tracked as part of the ongoing review of Crystal City's development under the Sector Plan adopted in September 2010. The discussion involved confirming what data would be collected by the county, rather than effective 'performance measures.' ARCA and AHCA representatives believe such measures should include a consistent approach to traffic data collection on roads and streets leading into and out of Crystal City, including Pentagon City, ARCA and AHCA. The current 2010-11 baseline data provided at the November 9 meeting (posted on the ARCA website) are based on tube counts which do not indicate month, day, exact location, or direction, and were mostly taken at five year intervals. We need a protocol for traffic data collection that will better support CCCRC metrics. We also need a measure for transit effectiveness that would tell us whether Transportation Demand Management (TDM) is succeeding in shifting trips from autos to transit. And we need information on pass-through traffic (on Rt. 1 and S. Glebe, for example), in coordination with VDOT. Subsequent small workgroups will hopefully address these and other concerns. Some items proposed for inclusion earlier, like slug carpooling, were dropped because the county does not collect data.

There are now a number of important community services for Crystal City which are shared with AHCA and ARCA—schools, emergency medical care, fire, police, library, theater—that do not have a metric, but will be in a category of items to be monitored as development proceeds. The same is true of retail needed to make Crystal City self-contained, such as grocery, hardware, child and eldercare. The method of monitoring needs to be determined. Potential increased pressure on ARCA's and AHCA's parks are also not reflected in the metrics, both because the county does not collect significant data on park use, and because they consider that increased use would be handled under the ARCA and AHCA Neighborhood Conservation plans.

Whether it was possible to have a useful metric for air quality in the CCCRC report was also discussed. Ultimately the majority decided that data from the Virginia DEQ monitor at Aurora Hills Community Center would not accurately reflect air quality directly resulting from possible increased traffic. National Airport, the Metrobus yard, West Virginia powerplants, I-395 traffic, etc. are heavy contributors, and there is currently no way to measure emissions from local CC traffic as a separate item. Nonetheless, air quality continues to be a concern of ARCA representatives. Co-chairs Christer Ahl and Judy Freshman said they plan to have the Council's first report completed and published in the spring of 2012.

### Pentagon Row Plaza Re-Design

Federal Realty presented revised plans for a re-design and upgrade of the plaza at the November 9 AHCA meeting. (Their Dec. 8 proposal is posted on the ARCA website). As previously reported, the winter-season ice rink would be lengthened but not widened, to 57' x 120,' making it about two-thirds of regulation size, which many who use the rink thought would be an improvement. The existing raised areas with grass would be removed to allow the bigger rink, but other play space would be added. Mature trees would be kept or replaced if weak; a proposed artificial turf lawn with curved path would replace current pavement. Two 800 sq. ft. freestanding retail spaces would be added, with nearby table and chair seating. Federal Realty says the retail will help cover the cost of the re-doing the plaza. Other features for seating, fountains, and play space would replace existing ones.

A fire pit and additional seating would be added, and outdoor warm season restaurant seating would remain. Attendees at the AHCA meeting expressed concern about pedestrian flow (especially during winter, when the rink is in place), viewing area for non-skaters, flexibility for families with small children, the heat island effects of artificial turf, and nature and quality of retail in freestanding buildings. A number of residents said they preferred real grass, but it would get dry and worn quickly, and require replacing every year. In spite of enthusiasm from a number of people, a majority of AHCA residents voted not to approve the plan. Federal Realty had made a number of changes in response to previous comments, and is making changes to respond to comments from County planning staff. They will submit their revised application at the January 21 County Board Meeting.
