Membership Meeting, Thursday July 16, 7pm

Plan to attend this critical membership meeting that will focus on the GLUP study of Vornado's request to up-zone and add 1,084 apartments to its River House property, as well as learn about the potential location of a new school in our neighborhood.

COUNTY REVIEW OF VORNADO RIVER HOUSE INITIATIVE MOVES FORWARD

ARCA members were informed at our July membership meeting that the County and its Planning Commission's Long Range Planning Committee (LRPC) would undertake a study to determine if Vornado's proposal to build another 1,084 apartments on its River House property would fall "within the realm of reasonableness," thus permitting amendment of the County's General Land Use Plan (GLUP) and re-zoning the property from residential to commercial. By doing so, Vornado (or some future owner) would become entitled to increase the property's density from 48 to 72 apartment units per acre and, potentially, to build very tall commercial buildings on the site in the years to come.

Subsequently, ARCA representatives met with County planning staff who assured them that the "scope" of the study would have to be far more comprehensive than prior GLUP studies given the magnitude and potential impact on our community of Vornado's development initiative. Exactly what the required "scope" of the study will be, and who will be responsible for conducting, supervising and funding the study is under discussion at the present time. It is not expected that LRPC review will commence before late October.

Meanwhile, ARCA has learned that County planning staff informed Vornado a year ago that any GLUP study would need to evaluate the impact of additional density "in the context of the significant development already approved [for construction] by the County Board for the Pentagon City area." Thousands of apartments have already been built, and thousands more have been approved to be built – many by Vornado – in Pentagon City, not to mention the many thousands of additional residential units and millions of square feet of commercial office space called for by the Crystal City Sector Plan. Vornado has also been granted the right to construct 1.8 million square feet of new office space on PenPlace. Whether and to what degree the County will now insist that the River House study evaluate the impact of yet more density **on top of** that which has yet to be built in 22202 remains to be seen.

A NEW SCHOOL IN OUR NEIGHBORHOOD -- WHAT DO YOU THINK?

The Arlington Public Schools South Arlington Working Group that is recommending locations for a new elementary school has identified six sites for consideration, including three in our neighborhood. These options are at Gunston Middle School, River House, and Virginia Highlands Park / Library /Community Center / former fire station (the specific location within this large area has not been identified). Vornado recently refiled its application to amend the County's General Land Use Plan (GLUP) to permit the redevelopment of its River House property to include plans for a potential elementary school on the southern portion close to 16th Street *in addition to* construction of 1,084 new apartments.

ARCA will update our membership about the status of this Site Selection process at its September 17th meeting and will also take an informal poll of our members' preferences. Concept designs have been developed for Gunston and River House but, to date, not for Virginia Highlands. Please come to learn more about this ongoing process and to share your opinion on a preferred site.

SEPTEMBER IS AFFORDABLE HOUSING MONTH Sat. Sept. 19, 9am County Board Public Hearings on Affordable Housing Master Plan

A proposed new Affordable Housing Master Plan will be considered by the Arlington County Board at a hearing on Saturday, September 19th. Despite Arlington's growing stock of housing (single family, duplexes, condos and apartments), it stock of

"affordable housing" has been seriously eroded. The proposed Plan would set a target of 17.7% of all

Arlington housing units to be "affordable" in years to come primarily by adding housing density. During September, the County will celebrate "Affordable Housing Month" with tours, forums and information fairs. Events include an Affordable Housing Bus tour of over a dozen properties; a Public Forum on Mixed Income Housing, its benefits and challenges; a two mile Bike Tour; and a forum that is a "nuts ad bolts teach-in" on Affordable Housing. SCHOOL BUSES HAVE "STOP SIGN" CAMERAS

Blowing past a school bus with its stop sign extended may result in a \$250 ticket if you are caught by one of the newly installed bus cameras. Arlington Public School's spokesman declined to say how many buses have the cameras, saying that revealing that information may encourage drivers to try their luck. The 6 cameras on each bus send their footage to the Police Department. One tolerant bus driver said that people don't stop because they are just not paying attention! So pay attention, slow down, or it might cost you \$250!
