### **ARCA QUESTIONS PENTAGON CITY DENSITY STUDY METHODOLOGY**

Shortly after Amazon announced its plan to locate its HQ2 that will house 25,000 employees in Pentagon City, the County Board finally recognized the need for an independent think-tank study of the ability of 22202's infrastructure to accommodate all of the new development and population growth coming to the area in the coming years. Indeed, ARCA had been seeking such a study for many years given that 22202's land mass is located within a geographic bubble that is accessible via only a scant few roadways that might eventually become unduly, or even dangerously congested.

However, County staff elected instead to focus the study on just Pentagon City even though most of the already authorized growth in 22202 is to be located in Crystal City where the number of residential units is scheduled to double and the commercial square footage to grow by 60 percent. Thus, staff arranged for one study to examine the capacity of just the multi-modal transportation infrastructure lying within and immediately adjacent to Pentagon City. And they arranged for a second study to determine whether the current ceiling on density in Pentagon City could be lifted, and if so, by how much. And while we are informed that the first study has not yet been completed, the second study was recently launched, and it seems to be engineered to secure public approval for additional development in Pentagon City. Thus, staff and the contractor scheduled a large public meeting at which they seemed to be attempting to manipulate the study's eventual outcome by whipping up public enthusiasm for density growth by seeking residents' advice on where to locate, and how to design large, new buildings for construction in Pentagon City.

There is just one problem. No determination has yet been made that **any additional density** beyond HQ2 and that which has already been approved for development, can be located anywhere in 22202, much less in Pentagon City. Talk about putting the cart before the horse!

It may come as no surprise that the density study is being funded by Pentagon City's commercial property owners and orchestrated by the County, all of whom would stand to benefit financially by the addition of more density via greater rental income and tax revenue. It's 22202's residential population that could see the livability of its neighborhood undermined were it to become unduly congested. Be assured, ARCA is doing its best to ensure that these studies are eventually completed objectively only after holistically analyzing all of 22202's infrastructure and the overall population density it will be able to accommodate within the entirety of 22202's land mass in the coming years.

### **ARCA 2021 BUDGET**

The covid-19 pandemic increased the difficulty in preparing this budget as revenue and expenses are harder to predict, but the Board of Directors decided to present a budget which represents a normal year, with the understanding that if the pandemic continues into 2021 we will have less revenue and fewer expenditures, with fewer donations to community events. We have not sent out paper newsletters because of concern for our delivery force, which has resulted in an elimination of printing costs. Also community financial support has decreased with fewer

## **LIVABILITY ROUTE 1**

**Improvements to Route 1** were part of Arlington County's agreement with Amazon, with several options discussed in August at a meeting with over 100 neighbors and stakeholders. The next step in this process is a Virginia Dept. of Transportation (VDOT) survey that is currently underway, in which residents and users of Route 1 are asked to help shape a study of potential future multimodal improvements between 12th and 23rd Streets South in Crystal City.

## **LIVABILITY OPEN SPACES**

### **Urban Garden Project in Virginia Highlands Park**

#### **1600 S. Hayes St.**

The Friends of Urban Agriculture (FUA) has been working with neighbors from Aurora Highlands Civic Association to create a demonstration urban garden, Highlands Urban Garden (HUG), in Virginia Highlands Park. It is a collaborative project with the National Landing BID, Livability22202, and Arlington County Department of Parks & Recreation. Project HUG is revitalizing underused land, showing how otherwise fallow spaces can be transformed into productive land that builds a vibrant ecosystem.

The small-scale garden will demonstrate modern sustainable agricultural practices, and a team of neighborhood volunteers will install, maintain and manage it. As a pilot site, the HUG will serve as a model for future community-driven agriculture features throughout Arlington's urban neighborhoods. <http://home.arlingtonurbanag.org/home>

### **Virginia Highlands Park Reflects Livability Open Space Initiative**

Aurora Highlands Civic Association (AHCA) with the help of the County Parks and Recreation Dept. and volunteers has turned the currently under-used Virginia Highlands

Park into a community asset with programs for all ages and interests. AHCA persuaded the County to remove some of the walls used to keep in softballs and keep out other users -- “The fields were significantly underused relative to other facilities”, they say, “Each field is used for only 600 hours per year, 14% of the time”. With greater casual use over the past 6 months, the space has been used to put into practice the Open Space priority in the Livability Framework, with a public space for art installations, social distance meetups, kite flying, exercising, and play space for families. . Also involved are stakeholders like JBG Smith, the BID, area businesses and restaurants. The need for open space is growing, especially with the imminent influx of new residents in the approved apartments to be built.

### **TEMPORARY DOG RUN IN VA HIGHLANDS**

The Virginia Highlands Temporary Dog Run project proposes to develop the space between the baseball diamond and the pétanque courts in Virginia Highlands Park into a temporary dog run. Originally proposed by Pentagon City Dogs last October, the dog run would include areas for both large and small dogs, fencing with screening in some areas, natural grass surfacing, double entry gates, maintenance gates, repurposed and ADA accessible benches, dog waste receptacles, a message board, The temporary dog park will also be reviewed annually to ensure it is operating safely and in accordance with the County’s policies regarding temporary park uses and facilities.

### **NATIONAL CEMETERY ADDS 70 ACRES**

A major project to add 70 acres to Arlington National Cemetery while reconfiguring the eastern end of Columbia Pike is moving forward. The cemetery's southern expansion project will add about 60,000 burial sites across 37 acres of new burial plots and an above-ground columbarium, allowing the cemetery to continue military burials through the 2050s. It will also bring the Air Force Memorial within the cemetery grounds, and add a parking garage across Columbia Pike. The federal government acquired county-owned land for the expansion via an eminent domain suit, and in exchange, the feds are paying for the reconfiguration of Columbia Pike and the creation of a new S. Nash Street in the tiny Foxcroft Heights neighborhood adjacent to the Air Force Memorial — a \$60 million project. The project will also transform Columbia Pike from S. Oak Street to Washington Boulevard by re-aligning and widening it. It includes streetscape zones with trees on both sides of Columbia Pike, adding a new dedicated bike path, and widening pedestrian walkways.

**ArlNow** reports that despite record-setting levels of early and mail-in voting, the final 2020 general election turnout in Arlington slightly underperformed that of 2016. It set a local record in terms of votes cast, but a rise in population and voter registration meant that the final turnout figure was a few points below the 82% turnout from 2016.

“In all, 131,518 voters, or about 79 percent of 166,416 registered voters, cast ballots on Nov. 3,” Arlington County said after all the votes were tallied. “In 2016, turnout was 82 percent (122,023 of 148,032 registered voters).” “Absentee turnout this year was record-breaking, with more than 108,394 Arlingtonians (65.1% turnout) casting their ballots by mail, drop box, or in person before Election Day,” the press release continues. “With so many Arlingtonians voting before Nov. 3, turnout remained light throughout Election Day, with only 23,124 people voting (14% turnout).”

### **GET YOUR HOLIDAY WREATH**

The Aurora Highlands Womens Club (AHWC) has a tradition of holding an annual fundraiser for local charities, where its talented members design and decorate custom wreaths. Due to the pandemic, however, they are unable to get together for this work, so they have instead partnered with Lynch Creek Farm to provide the wreaths. This year the funds raised will be go to two charities, the Hume School building, which houses the Arlington Historical Museum and the Arlington Food Assistance Center. Wreaths are delivered directly to you or your friends and family with nationwide delivery. With the wreath sales, AWHC has provided over \$147,000 in donations to local organizations over the past ten years.

## **AHC INSTALLS SOLAR PANELS ON S. GLEBE RD. APARTMENTS**

The 130 kilowatt installation will generate enough electricity to offset common area energy usage. The Apex is a 5 story 2 building complex that opened this spring, with 256 affordable units.

### **WHAT TO DO WITH YOUR LEAVES**

Leaves form a natural mulch that helps suppress weeds and fertilizes the soil as it breaks down, says the National Wildlife Federation. Removing the leaves eliminates vital wildlife habitat for turtles, toads, songbirds and invertebrates that rely on leaf litter for food, shelter and nesting material. Those fall leaves could also form an essential part of your “lasagna garden”: a garden where you’re trying to build soil, not grow plants, and is a no-dig, no-till organic gardening method that results in rich, fluffy soil with very little work from the gardener.” In the fall, place cardboard over the top of weeds, wet it down, and then add layers of organic material such as grass clippings and leaves. You’ll have a thriving soil ecosystem come the spring.
