ARCA BYLAWS VOTE UPDATE

ARCA By-Laws are in need of updating. Please come and vote in person on this important issue.

A recent ARLnow article on civic engagement in the county noted that current ARCA membership by-laws require being a property owner for membership, with renters who live within the association boundaries and wish to join must be approved by the executive board. That provision discourages a large number of current residents who rent. Please note that renters are members of our community, are welcome to attend our public meetings, and we would like to encourage them to join without an additional approval process. The process to amend ARCA's by-laws requires an **in-person vote** by 2/3 of members present with notice of proposed changes must be sent to the membership ahead of the meeting. We will be discussing the membership rules change at the March meeting, we hope to see you there, 7 - 9 pm.

The following is the existing by-law text with the portions to be amended struck through:

ARTICLE II BOUNDARIES AND MEMBERSHIP

Section 2. *Regular Membership*. All adult property owners adults who also reside within the boundaries of this Association shall be regular members of this Association. All adults owning and residing in property on any street which is a common boundary between this Association and any contiguous association shall be regular members of this Association or of the contiguous association, as they may elect; provided, however, that such persons shall not be eligible for membership in both associations.

REMOVED Adults residing in the Association area who are not real property owners may request regular membership subject to approval by the Association's Executive Board.

"HOT SPOTS!" IN OUR NEIGHBORHOOD https://www.arlingtonva.us/Government/Programs/ Transportation/Vision-Zero/Maps-and-Safety-Data#section-5

Arlington's **Vision Zero** identifies "hot spots" in the County that have a relatively high crash rate, using data from 2018 – 22, so crash mitigation measures can be taken. Hot spots are identified for vehicle, bicycle, and pedestrian crashes. 22202 and adjacent location spots are (no surprises here!) Rt. 1 and 23rd St.; S. Hayes & Army Navy Dr; S.Glebe and the 395 off ramp; S. 15th and Eads St.,; S. Glebe and 26th Rd. S. 395 off ramp. Check the County's website for full details.

MISSING MIDDLE CASE HEADED TO TRIAL https://www.arlnow.com/2024/01/16/arlingtoncounty-loses-pretrial-appeal-in-missing-middlesuit/

A group of 10 homeowners sued Arlington on its Missing Middle zoning amendment, arguing that the county violated state law and didn't properly consider its impact on individuals. Arlington County appealed this decision to allow the suit to go forward saying the 10 residents did not have standing to sue. Arguments over standing, and attempts by the county to dismiss the lawsuit, have failed, and a trial is set to begin July 8. Funding the litigation is the group Arlington Neighbors for Neighborhoods.

LIVABILITY22202 REBOOT UPDATE

The three civic associations who comprise the Livability22202 coalition sent a letter to Senator Adam Ebbin on our concerns with the proposed Monumental Sports and Entertainment campus. "While there are many concerns", they write, "The greatest are transportation and safety...the transportation management plan is woefully insufficient and does not consider impacts beyond Alexandria, using Arlington to absorb the expected increase in traffic". Two-Theater Venue is also an issue for us as the lease on the Crystal City space being used by prizewinning Synetic Theater has not being renewed by JBG. The advocacy group **Embracing Arlington Arts** has identified a potential investor/financial partner seeking to fund a cultural project that also includes housing units. In the past, Arlington County has been helpful to the arts community in identifying developers who might fall

into this category – for example the Rosslyn Spectrum and Signature. (With the much vilified Artisphere, the County made serious mistakes after the space had been given to it rent free for 15 years, unfortunately during a time of budget downturn and staff cutbacks.) Remember: Ars longa vita brevis (art is long, life is short)
